# A. Psychological Evaluation Update / Dr. Forsberg

At the last Executive Board meeting there was a request that Dr. Linda Forsberg address the board regarding the psychological evaluations her organization performs. First she began by talking about her credentials and why she is qualified in this particular field. She went on to talk about the process involved:

- Written portion
   The applicant completes a battery of psychological tests including a cognitive (problem solving) test.
- Background portion
   The applicant completes a background questionnaire
- Psychological evaluation / Interview

Dr. Forsberg stated a pre-employment evaluation can find issues related to job performance, reliability, maturity, flexibility, tolerance for differences, social skills, working with a team and independently when needed particularly in the field of dispatching as well as work under extreme stress.

Dr. Forsberg was asked for her 'opinion' when selecting a psychologist for a second opinion. She responded by saying the person should be someone that specializes in the field, understands the legal consequences and someone that can be trusted. When asked what her recommendation would be Dr. Forsberg responded by suggesting Mr. Fayling should have the final decision and that it would be at his discretion to contact both psychologists to obtain further information if needed to come to a decision.
